# SUBSIDISED AND FREE ACCOMODATION GUIDELINES

These guidelines are intended to set out the circumstances under which free or subsidised accommodation is available to Club members.

### GENERAL GUIDELINES

Accommodation cost reimbursement is done retrospectively. I.e. accommodation is paid for as normal and a credit is given after approval by the committee. An exception is where free accommodation is associated with scheduled work parties. Here accommodation charges are not required to be paid up front. Additional exceptions may be made at the committee's discretion.

In circumstances where the CAC has exhausted its annual budget for free and subsidised accommodation the committee reserves the right to reduce the level of accommodation subsidisation.

# **WORK PARTIES**

#### SCHEDULED WORK PARTIES

People attending scheduled work parties are given complimentary accommodation for the Friday and Saturday nights. Both members and non-members are eligible for free accommodation at scheduled work parties. No application is required for waiver of accommodation charges at scheduled work parties.

#### **UNSCHEDULED WORK PARTIES**

Free accommodation for members at unscheduled work parties is normally granted, however is also at the discretion of the committee.

Unscheduled work parties should be notified to the Committee (in advance if possible), with an indication of the expected work to be performed and attendees. The decision to waive or reimburse costs for unscheduled work parties is to be made by committee resolution for specific events and people. Non-members (including people on the waiting list) will not normally be granted free accommodation at unscheduled work parties, however the committee may choose to subsidise fully or partially that accommodation.

Where possible, committee approval for subsidised or free accommodation should be gained before the unscheduled work party. However, it is recognised that this may occasionally not be feasible. In such cases approval must be sought retrospectively.

Committee members and one accompanying member of their immediate family are not charged for accommodation for committee meetings held at lodges. Free accommodation is limited to one night per relevant committee meeting.

## **EVENTS**

Free accommodation associated with Club and external social and sporting events is notionally limited to 72 beds per season.

There is a standing decision to reimburse accommodation costs for the following people:

- Members who race for the Club in the Balmain Cup (up to two nights each)
- Members who race for the Club in the Perisher Cup (up to two nights each)
- Event Officials for the Balmain Cup (up to two nights each)
- Event Officials for the Perisher Cup (up to two nights each)
- Junior Week co-ordinators one each at Perisher and Jindabyne if required (six nights maximum for coordinator at each lodge - accounted for as part of the cost of organising Juniors' Week - may be split among several individuals)
- Youth Week co-ordinators one each at Perisher and Jindabyne if required (six nights maximum for coordinator at each lodge - accounted for as part of the cost of organising Youth Week - may be split among several individuals)
- Championship Dinner organiser one person for one night
- Brumby Cup Dinner organiser one person for one night

A formal application from persons in the above positions is not required for reimbursement of accommodation charges, however those seeking full or partial subsidisation of accommodation should ensure that the appropriate sub-committee is aware of that intention.

The decision to reimburse costs for people other than those listed above is to be made by committee resolution for specific events.

## **EXTERNAL EVENTS**

Free or subsidised accommodation may be granted to members who are organisers or officials of major external events, where the organisation responsible does not provide or reimburse accommodation (E.g. State or National Championships, or an event sponsored by the Club). Applications should be in writing to the Committee, however the committee may make a grant of accommodation despite the absence of a written application.

# SKI DEVELOPMENT PROGRAM

Club members in receipt of Ski Development Assistance (at either a competition or elite level) may be granted subsidised accommodation. The subsidy will normally be; adults and youths at junior rates, and juniors free.
